



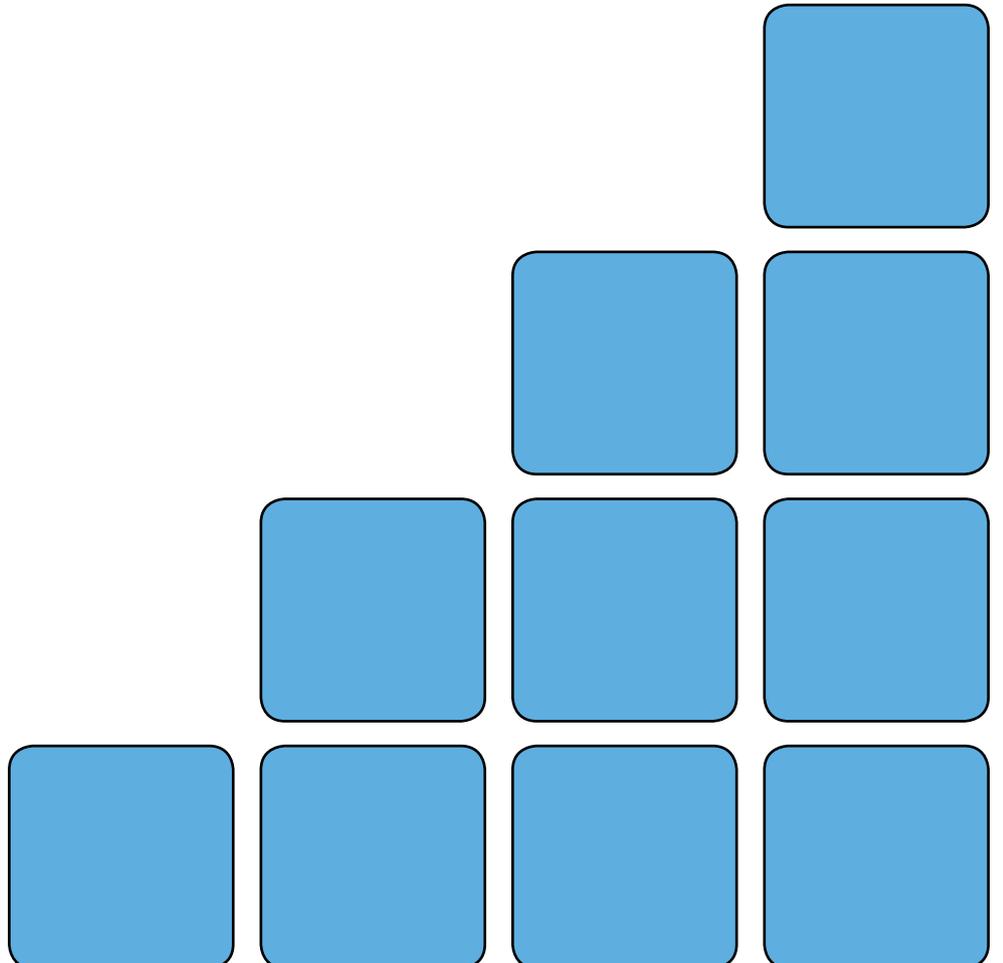

Carry out waxing services

This unit is about removing hair using waxing techniques. The areas to be treated include the eyebrows, face, legs, underarm and the bikini line. You will need to be able to consult with the client, prepare and plan for the service. You will also need to provide aftercare advice to the client, particularly around the avoidance of certain activities and the use of home care products.

To carry out this unit you will need to maintain effective health, safety and hygiene throughout your work. You will also need to maintain your personal appearance and demonstrate effective communication and consultation skills.

The main outcomes of this standard are:

1. Maintain safe and effective methods of working when removing hair by waxing
2. Consult, plan and prepare for waxing services
3. Remove unwanted hair

Evidence requirements

1. *Environment*
Evidence for this unit may be gathered within the workplace or realistic working environment (RWE).

2. *Simulation*
Simulation is not allowed in this unit.

3. *Observation outcomes*
Competent performance of Observation outcomes must be demonstrated on **at least four occasions**, each involving a different client.

Assessor observations, witness testimonies and products of work are likely to be the most appropriate sources of performance evidence. Professional discussion may be used as supplementary evidence for those criteria that do not naturally occur.

Assessed observations should not be carried out on the same day for the same learning outcome. There should be sufficient time between assessments for reflection and personal development.

You need to meet the same standard on a regular and consistent basis. Separating the assessments by a period of at least two weeks is recommended as competence must be demonstrated on a consistent and regular basis.

4. *Range*
All ranges must be practically demonstrated or other forms of evidence produced to show they have been covered.

5. *Knowledge outcomes*
There must be evidence that you possess all the knowledge and understanding listed in the Knowledge section of this unit. In most cases this can be done by professional discussion and/or oral questioning. Other methods, such as projects, assignments and/or reflective accounts may also be used.

6. *Tutor/Assessor guidance*
Your tutor **must** refer to the '**Habia Assessment Strategy**' when delivering this unit to ensure that you cover all the requirements for this unit. This can be found on www.vtct.org.uk under the relevant qualification page.

You will be guided by your tutor/assessor on how to achieve learning outcomes and cover ranges in this unit. All outcomes and ranges must be achieved.

7. *External paper*
Knowledge and understanding in this unit will be assessed by an external paper. **There is one external paper that must be achieved.**

Achieving observations and range

Achieving observation outcomes

Your assessor will observe your performance of practical tasks. The minimum number of competent observations required is indicated in the Evidence requirements section of this unit.

Criteria may not always naturally occur during a practical observation. In such instances you will be asked questions to demonstrate your competence in this area. Your assessor will document the criteria that have been achieved through professional discussion and/or oral questioning. This evidence will be recorded by your assessor in written form or by other appropriate means.

Your assessor will sign off a learning outcome when all criteria have been competently achieved.

Achieving range

The range section indicates what must be covered. Ranges should be practically demonstrated as part of an observation. Where this is not possible other forms of evidence may be produced. All ranges must be covered.

Your assessor will document the portfolio reference once a range has been competently achieved.

- a. Maintain your responsibilities for health and safety throughout the service
- b. Prepare your client and yourself to meet legal and organisational requirements

- e. Position your client to meet the needs of the service
- f. Ensure your own posture and working methods minimise fatigue and the risk of injury to yourself and others
- g. Ensure environmental conditions are suitable for the client and the service
- h. Keep your work area clean and tidy throughout the service
- i. Use working methods that minimise the risk of cross-infection
- j. Ensure the use of clean equipment and materials
- k. Promote environmental and sustainable working practices
- l. Follow workplace and suppliers' or manufacturers' instructions for the safe use of equipment, materials and products
- m. Dispose of waste materials to meet legal requirements
- n. Complete the service within a commercially viable time

Learning outcome 2

Be able to consult, plan and prepare for waxing services

You must be able to:

- a. Use consultation techniques to determine the client's service plan
- b. Ensure that informed and signed parental or guardian consent is obtained for minors prior to any service
- c. Ensure that a parent or guardian is present throughout the service for minors under the age of 16
- d. Recognise any contra-indications and take the necessary action
- e. Agree the service and outcomes that meet the client's needs
- f. Obtain signed, written informed consent from the client prior to carrying out the waxing service

Learning outcome 3

Be able to remove unwanted hair

You must be able to:

- a. Apply pre-wax products to the treatment area
- b. Conduct a thermal test patch immediately prior to the waxing service
- c. Establish the hair growth pattern and trim over-long hair prior to the application of the wax
- d. Apply wax, minimising the risk of cross-infection and contamination
- e. Apply and remove the wax according to the requirements of the hair removal method and hair growth patterns
- f. Ensure your work techniques minimise discomfort to the client
- g. Check the client's wellbeing throughout the waxing service
- h. Ensure the treatment area is left free of wax and hair and treated with an after-wax product
- i. Ensure that the finished result is to the client's satisfaction
- j. Give your client advice and recommendations on the services provided
- k. Ensure the client's records are completed and signed by you and the client

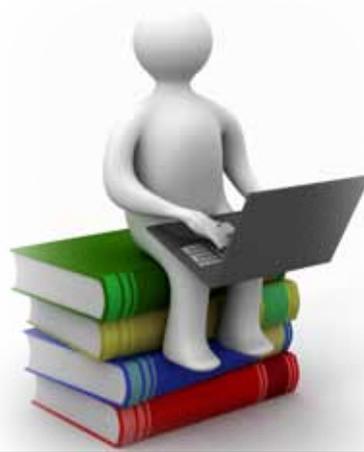
