





Provide a variety of relaxing services

This unit is about providing prescriptive relaxing services. The ability to analyse relaxing issues, deal with chemically treated hair, sensitised hair and plan and agree a course of action is required, as treatment may need to span a period of time and a number of appointments.

To carry out this unit, you will need to maintain a high level of health, safety and hygiene throughout your work. You will also need to maintain a professional personal appearance and demonstrate effective communication skills.

The main outcomes of this unit are:

Evidence requirements

1. *Environment*
Evidence for this unit may be gathered within the workplace or realistic working environment (RWE).
2. *Simulation*
Simulation is not allowed in this unit.
3. *Observation outcomes*
Competent performance of Observation outcomes must be demonstrated on **at least four occasions**. Assessor observations, witness testimonies and products of work are likely to be the most appropriate sources of performance evidence. Professional discussion may be used as supplementary evidence for those criteria that do not naturally occur.

Assessed observations should not be carried out on the same day for the same learning outcome. There should be sufficient time between assessments for reflection and personal development.

You need to meet the same standard on a regular and consistent basis. Separating the assessments by a period of at least two weeks is recommended as competence must be demonstrated on a consistent and regular basis.

4. *Range*
All ranges must be practically demonstrated or other forms of evidence produced to show they have been covered.
5. *Knowledge outcomes*
There must be evidence that you possess all the knowledge and understanding listed in the Knowledge section of this unit. In most cases this can be done by professional discussion and/or oral questioning. Other methods, such as projects, assignments and/or reflective accounts may also be used.
6. *Tutor/Assessor guidance*
Your tutor **must** refer to the '**Habia Assessment Strategy**' when delivering this unit to ensure that you cover all the requirements for this unit. This can be found on www.vtct.org.uk under the relevant qualification page.

You will be guided by your tutor/assessor on how to achieve learning outcomes and cover ranges in this unit. All outcomes and ranges must be achieved.

Criteria may not always naturally occur during a practical observation. In such instances you will be asked questions to demonstrate your competence in this area. Your assessor will document the criteria that have been achieved through professional discussion and/or oral questioning. This evidence will be recorded by your assessor in written form or by other appropriate means.

Your assessor will sign off a learning outcome when all criteria have been competently achieved.

Achieving range

The range section indicates what must be covered. Ranges should be practically demonstrated as part of an observation. Where this is not possible other forms of evidence may be produced. All ranges must be covered.

Your assessor will document the portfolio reference once a range has been competently achieved.

You must be able to:

- a. Maintain your responsibilities for health and safety throughout the service
- b. Prepare your client to meet salon's requirements
- c. Protect your client's clothing throughout the service

- e. Ensure your own posture and position whilst working minimises fatigue and the risk of injury
- f. Keep your work area clean and tidy throughout the service
- g. Use working methods that:
 - Minimise wastage of products
 - Minimise the risk of cross-infection
 - Make effective use of your working time
 - Ensure the use of clean resources
 - Minimise the risk of harm or injury to yourself and others
 - Promote environmental and sustainable working practices
- h. Ensure your personal hygiene, protection and appearance meets accepted industry and organisational requirements
- i. Follow workplace and suppliers' or manufacturers' instructions for the safe use of equipment, materials and products
- j. Dispose of waste materials
- k. Complete the service within a commercially viable time

Learning outcome 2

Be able to analyse the hair and scalp

You must be able to:

- a. Use analysis techniques to establish the nature and extent of the relaxing service required by your client
- b. Identify from your client's previous records, where available, their hair history and how this may affect the relaxing service
- c. Ask your client questions to identify if they have any contra-indications to relaxing services
- d. Ask your client questions to gather information on their relaxing issues and the result they would like to see
- e. Record your client's responses to questioning
- f. Conduct a range of tests on your client's hair and skin following manufacturers' instructions and recognised industry procedures
- g. Take a suitable course of action when contra-indications and/or reactions to tests cause doubts to the suitability of the relaxing service for the client
- h. Identify available service options and products for resolving your client's relaxing issues based on the results of your analysis

Learning outcome 3

Be able to plan and agree a course of action

You must be able to:

- a. Present suitable options for a course of action in a way your client will understand
- b. Base your recommendations on the results of your analysis
- c. Explain the likelihood of achieving and maintaining the required degree of straightness to your client
- d. Explain any restrictions your recommendations may have on further hairdressing services
- e. Gain and record your client's agreement to the service, products and anticipated outcome
- f. Choose products and tools based on the results of your analysis, tests, consultation with your client and factors influencing the service
- g. Prepare products following manufacturers' instructions
- h. Protect the hairline and scalp prior to relaxing
- i. Apply a pre-relaxing treatment to even out the hair porosity or protect previously chemically treated hair

Learning outcome 4

Be able to provide relaxing services

You must be able to:

- a. Prepare your client's hair for the:
 - Products to be used
 - Relaxing service required
 - Method of application
 - Manufacturers' instructions
- b. Select and use relaxing products from the same product line throughout the service following the manufacturer's instructions
- c. Apply the type and quantity of product to meet the requirements of your analysis and the required result
- d. Carry out the relaxing service, taking account of influencing factors
- e. Use application techniques that minimise the risk of relaxer being spread to the client's skin, clothes and surrounding areas
- f. Frequently monitor the development of the product, taking strand tests, as required
- g. Modify and adapt your planned course of action to resolve any unforeseen problems
- h. Monitor the comfort of your client at regular intervals throughout the relaxing service
- i. Achieve a degree of straightness anticipated
- j. Remove chemicals in a way that minimises the risk of damage to the hair by following manufacturers' instructions
- k. Adapt the water temperature, pressure and direction to protect the hair condition
- l. Restore the hair's pH balance using a suitable post relaxing treatment
- m. Give your client advice and recommendations on the service provided


